

LIGHTNING DATA CENTER MINUTES

December 13, 2024

ST. ANTHONY HOSPITAL, LAKEWOOD, COLORADO

Members present: Clark, Yarnell, Swanson and Langford. Meeting began at 11:45 AM and ended at 12:35 PM.

1. The LDC is accepting donations, either as cash or check. If you donate via check, please make your check payable to Steve Clark at 755 S. Clinton Street, #2A; Denver, CO 80247. He will cash the check and keep the cash holdings specifically for the LDC. When the LDC incurs expenses, Steve will pay for services rendered through his bank account using the cash from LDC’s cash holdings. A log will be maintained detailing the inflow and outflow of monies. LDC currently has \$347.00 in cash.
2. Paragraphs 2-6 are from the December meeting. It is official. The LDC is no longer affiliated with St. Anthony Hospital or their corporate parent, CommonSpirit. Under Centura, the former corporate parent, LDC was a “Standing Committee”, one of several. With the change of corporate parents from Centura to CommonSpirit, the decision makers at CommonSpirit dissolved all of the Standing Committees, including us.
3. Since we are now a stand-alone entity, my thought is to form a true 501c3 entity. The question is: What kind of 501c3 entity do we want to be, if at all? There are a couple of advantages of having a 501c3 entity. It will be easier to pursue grants and potential donors are more apt to give if they see we are a truly legitimate 501c3 entity. My preference is to form a “lean and mean” organization with a bare minimum of paperwork and bookkeeping. What would you like to see? Please e-mail me with your thoughts at: sclarktoto@gmail.com. Loraine, Carl Swanson’s fiancée, has experience in setting up 501c3 organizations. She told us to expect having to do some or all the following if we start a 501c3 organization: Pay a registration fee (and possibly renewal fees), name a minimum of three individuals to officer positions, explain how our meetings work and explain how decisions are made within the organization.
4. Regarding meeting announcements and minutes, those will come directly from me from the e-mail address above. I expect to send two sets of meeting announcements each month – the first approximately two weeks before the meeting and the second about 20-25 minutes before the meeting. The first one WILL NOT have a link to the meeting, but the second one will.
5. Remember, LDC meetings will be held via Skype. Instructions for joining Skype meetings were e-mailed to the membership on December 5, 2024. It is possible modifications to the instructions will be needed depending on what, if any tech issues pop up. Stay tuned on that.

6. Speaking of tech issues, we had some with the December meeting. Ken Langford and Phil Yarnell could not get their displays to appear for all of us to see. They could only see themselves on their devices. I will be working with both in the coming months to address these problems.
7. Meanwhile, there have been some lightning and electric shock matters in the news.
8. In Commerce City, Colorado, police were looking for a man who cut a wire in a transformer, received a shock, and walked away. Officers found a bicycle and the charred remains of clothing. A video from the area of the transformer showed two explosions and somebody walking away from the transformer. The cutting of the wire caused damage to the infrastructure. The article incorrectly said the man was electrocuted, but if that were true, he would be dead. To date, it appears the suspect has not been caught.
9. Robert Gift brought to our attention two incidents of lightning striking at football (soccer) matches in Africa during the same weekend in 2023. In the Democratic Republic of Congo, 11 players were struck and killed by lightning – all on the visiting team. Players from the home team, Basanga, were unharmed. In Johannesburg, South Africa, half of the players from both teams were struck and fell to the ground in pain. Thankfully, no one died from that strike. Details about the Johannesburg incident could not be found online in South Africa newspapers.
10. Colorado ranch hand JD Corley was struck by lightning at approximately 9 AM on September 17 while working at a ranch located about 4 miles south of Durango, Colorado, in the southwest corner of the state. Later, the ranch owner and another worker went looking for Corley after seeing Corley's dog lying by the barn, which was unusual since Corley and the dog were almost always together. They found Corley lying face down on the ground about 300 yards behind the barn. His clothes were shredded, with fragments of the clothes found 30 to 40 feet away from where he was found. The bill of his baseball cap was torn away from the remainder of the cap.

Corley was conscious but incoherent and he was in severe pain. He was taken to Mercy Hospital but was in critical condition and had to be flown to University of Colorado Hospital in Denver. Both legs were burned and there are two fractures in his skull – one on each side with the bone fragments pointing outward. One eardrum was torn and there was some bleeding. As of October 6, he was still in the hospital working to regain memory.

11. On July 31, 2024, lightning struck during a football match at the Oweko Primary School in the Nebbi District, located in northwest Uganda, where multiple schools were participating. There were 79 injuries (2 adults and 77 students). Of the injured, 18 were taken to Oweko Health Centre 1 and another 7 in critical condition were taken to Nebbi Referral Hospital. An investigation was conducted with interviews of the survivors, witnesses, teachers and district officials. A heavy rain had begun to fall and people sought shelter inside a classroom similar to that shown below, with several more standing outdoors on a veranda. The lightning hit and most of the people on the veranda were affected. Some were thrown several feet and came-to in the mud.



This is a very poor community, even by Uganda standards. Our team found that it is not unusual for 70 or more children to be packed into a classroom designed for 30-45 students.

During the investigation, 36 pupils were interviewed along with the two adults, a cook and a teacher. Amnesia was commonly reported. The teacher was the most severely injured, with confusion, amnesia and trouble with understanding her husband's requests. She has not returned to work. The cook has returned to work after feeling numb and weak on one side. Four students were interviewed and their information was listed in the article. Three of the four were standing under the veranda and the fourth was running to take shelter under the veranda when the strike occurred. All four experienced temporary keraunoparalysis after the strike. Other sequelae included leg pains when standing or walking, photophobia, teary or moist eyes – especially when in the presence of bright objects or light. They also had arm pain, sleep disturbance and PTSD.

12. In October, we were supposed to meet with the father of a son that was recently struck by lightning. On the morning of October 11, the son was readmitted to the hospital and thus the father could not attend. Our prayers are with the son as he goes through a very difficult time. Barbara Brewer, who introduced the father and son to the LDC, said the son had been playing in a soccer match when a storm came in. The team sought shelter in the locker room and then the coaches decided it was okay to resume activity. The son went back onto the playing field and was hit. Barbara said 30 minutes had not elapsed from the time of last lightning or thunder when the team went back onto the field. He had rhabdomyolysis, his kidneys were bad and his blood pressure was high. He is able to walk but has bad muscle spasms. He had pain in his thigh muscles. His readmission to the hospital was due to extreme pain.

13. During the fall of 2023, Thalita Teixeira Padilla was hit by lightning while walking her dog on a Boston area beach. She had been thrown into the air and had burns, nerve damage and a spinal cord injury. She was admitted to the hospital on September 9, 2023 and a month later was in a rehab facility learning how to walk again. Sometime in July 2024, she began to feel less pain and now is able to walk with a walker.
14. Paragraphs 15-20 are from the October 2024 meeting.
15. Barbara Brewer provided us with an update on her son Jacob. He is still numb from his knees down to his feet and he cannot move his feet. Other than that, he is recovering very well. Jacob has his gluts, hamstrings and quads back and his upper extremities are good. His bowel and bladder are functioning properly. He is now attending college online at LSU-A and is doing very well there.
16. Randy Price gave us an update on his condition. He was the fellow struck inside the radio shack where he was working as a traffic controller for cargo ships, similar to an air traffic controller for airplanes. He still has cardiac damage. His heart rate is typically 80-90 bpm, but it can soar to around 160 bpm when he stands up. He still has liver damage.
17. We had a brief discussion on pain medications. According to Barbara, Lyrica aka Gabapin is usually the first medication given to lightning survivors for pain. Barbara began to use natural remedies when she found the traditional remedies were not working for her son.

Dr. Phil Yarnell mentioned a few other medications that are potentially helpful depending on the circumstances:

Trileptal is an anticonvulsant used to treat seizures.

Tizanidine is a muscle relaxant for the treatment of muscle spasms. Muscle relaxants can also be used for muscle soreness.

For topical pain, lidocaine is a local anesthetic which can be used to treat abnormal sensations and pain in the skin. It is available over-the-counter or via prescription.

18. Howard Wachtel recently had a close call with lightning while he was inside his house. He said there was a big storm, when everything around him lit up simultaneously with a sharp crack of thunder. Howard was struck by the loudness of the sound, as he noted thunder usually has a more rolling sound. He said there was no gap between the lightning and the thunder.

Howard also recalled a lightning safety issue at a public swimming pool in Boulder, Colorado. When lightning threatens, people are told to evacuate the premises. In the August 2012 minutes, Howard had said people were told to take shelter under trees when lightning threatens.

19. Linda Cooper told us she wants to see lightning education being taught in elementary school when the kids are studying weather. She occasionally gives lightning talks to school-age kids. She says oftentimes, the parents are clueless about lightning safety. She said she doesn't talk about being struck very much in public because most of the time, people do not believe her.

20. Linda also told us one of the principals at a school was struck by lightning while telling school buses to move.
21. In closing, I apologize for the hiccups in getting the minutes to you, the members. LDC is clearly in a state of transition and I greatly appreciate your patience as we stumble and bumble through this period. Hang in there! Things will get better!
